On Thursday 9 January 1997, I was directed to be part of the enquiry team investigating the murder of Mrs Marion Ross, 43 Irvine Road, Kilmarnock.

As part of the enquiry, I was instructed to re-interview the witness, [Redacted] in particular in relation to which door the windows on either side Mrs Ross's house.
